Applications must include your name, position applied for, statement of claim (why you want the role and what you will bring to the role). Names of applicants will be shared with members via surfguard prior to the meeting.

Members nominating for Agenda Item 6 & 7, MUST BE FINANCIAL at the time of nomination and eligible to vote at the 2024.25 AGM. If a position is not nominated for in writing, that position will remain vacant until a later date. NO NOMINATION WILL BE ACCEPTED FROM THE FLOOR. A CLOSED BALLOT will be held for the positions irrespective of the number of candidates. This ensures that the membership has a vote on the suitability of that candidate.

To vote at the AGM, a member must be; (i) financial member of TSLSC for 2023/24season, (ii) an active member 15 years or over on the day of the meeting; (iii) a Life Member or Board

Member; or (iv) a current Associate Member with a minimum of 3 consecutive of seasons TSLSC membership. There will be no proxy voting.

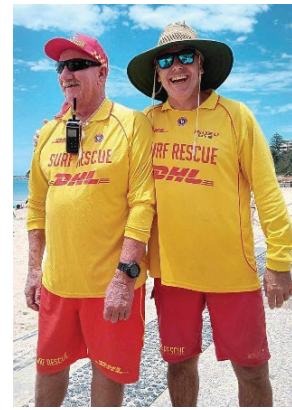

PRESIDENT'S REPORT

We have had a busy season and I would like to thank all our patrolling member for the efforts that they have put in during the season. **I am absolutely thrilled for Terrigal SLSC to have won the SLSCC, SLSNSW and Surf Life Saving Australia Club of the year awards.** This was a first for the club winning at Branch level and then was a thrill to go on and win the NSW award but to win the Australian Surf Life Saving Club of the year was beyond my comprehension and is testament to all the hard work the club has put in over recent years. In particular, the 2023/24 season was transformational. This was a huge honor and I am thankful to all our Board and members for all they do day-in, day-out. I would also like to thank Julie Redfern for her tireless work preparing our documentation. Also, to Adam Montgomery, Julie Redfern and Jayden Redfern who were our representatives at the SLSA presentation and interview. This was a huge challenge and the team did the club extremely proud. Success in winning these awards are a massive team effort.

Our beach is busy with many tourists; saw an estimated 154,894 visitors and 34,916 'swimmers' this season. We have 778 members (41% female). We again had zero drowning deaths and our volunteers performed 9253 patrol hours, 2417 preventions, 212 first aids and 22 rescues. We worked hard in training of members and now have many highly trained lifesavers 274 BMs, 135 IRB crew, 92 IRB Drivers, 127 ART, 79 SM Beach Management, 6 RWC.

This season we have transformed our processes and governance via strategic initiatives. We realised we were spinning our wheels on 'little things' and being reactive so we changed our approach to ensure TSLSC has a strong and sustainable frontline AND 'back of house'. Our new Constitution was passed at the 2023 AGM and we have now developed a range of Policies that sit alongside it. These include improvements in Life Membership nomination process, voting rights and other processes. We digitised Annual reports for the past 50 years 'searchable' and openly available via SLSA member portal/website. We are moving to paperless with implementation of electronic meeting communication for improved record-keeping. Our Board has tried to focus more on strategy and operations which has also improved alignment with SLSNSW processes and policies.

To maximise member engagement, retention and enjoyment we expanded opportunities within and beyond SLS. Initiatives included 'Gold Medallion Numbered Caps' where we adapted the competition strategy used by other clubs to instead reward and encourage Lifesaving achievement. We presented 23 past/present Gold Medallion holders a numbered red/yellow cap and listed on clubhouse Honor Board. We implemented a new approach to SRC/BM – supporting and encouraging parents and new members with training, knowledge, practical skills. We also opened our clubhouse to enhance socialising – implemented regular opening hours, happy hour, music, held member social functions with food and drink. We offered training opportunities to our youth in bar work/training and DJ work and we supported 8 to become Development coaches in SLS. Our athletes also performed well. In surf sports we hosted 4 carnivals, won Branch Open carnival and won medals at NSW and Australian levels.



This season, we commenced the long-awaited clubhouse renovation. We have worked extremely hard to make this a reality on minimal funds where the goal is to balance functionality and cost. In December 2023, the first floor bathrooms were completely renovated. In early 2024, Board members were successful in being a variation and extension to the NSW Sport and Recreation Grant and completed a tender process, Unique Building Partners were the successful construction company. The construction work commenced in August 2024. Ongoing works are due for completion in late 2024 and include a new entrance and foyer, whole new function/training room, expanded ground floor bathrooms, new bar countertop, furniture, AV and various other improvements. The works also provide the café with a new coolroom and drystore directly adjacent to their kitchen which improves café efficiency and prevents the need to café staff and storage in the TSLSC. This project has been 20 years in the making and is supported by volunteer fundraising over many years.

At Terrigal SLSC, we have also supported a range of community initiatives. For example, we partnered with the Clontarf Foundation and together we enabled a group of 15 Indigenous men to be rewarded with a 'camp' at TSLSC (09/2023). These young men learned about surf safety from TSLSC members and experienced the power of community philanthropy. We also partnered with Legacy children and families attending our club so young people had a chance to play, swim, board-paddle at Terrigal Beach in a safe and education-focused environment. Our Ocean Swim was yet again a big success with around 700 swimmers on Easter Saturday in 2024. With perfect conditions and weather, everyone enjoyed the event which is also a major fund-raiser. Alongside, the Ocean Swim we also supported the NSW Cancer Council by hosting the Daffodil Dip that raised much needed funds for cancer research and care. In addition, we have maintained our clubhouse as a community facility with groups such as Bay2Bay, Council, Local Police, 5-lands walk, Flavours by the sea, Terrigal/Wamberal RSL (ANZAC Day Dawn Service), all being able to deliver for their community in the heart of Terrigal.



In recognition of our members we made several OAM nominations with Cathy Cole being awarded an OAM on Australia Day 2024. We had 98 SLSA awards given to 72 members: 59 Patrol Service Awards, 6 National Medals, 16 SLSA Long Service Awards (including 2x50-years, Peter Wylie for 80-years service). We were also awarded a Department of Veterans Affairs 'Saluting their Service Grant' (led by Paul Quick) to forever recognise Terrigal SLSC members who have served overseas. We continue to communicate regularly with our members via surfguard, our newsletter (BluesNews) and we have a growing and active social media presence. Our Facebook page has 3502 followers, club Instagram has 1938 followers. We recently set-up TripAdvisor to promote to tourists and our young women set-up "Terri.gals" on Instagram to foster engagement. This attracted much interest during the SLSA livefeed and we love supporting our youth in expanding/leading these strategies.

I am extremely thankful to our whole Board who work so hard for our club and surf lifesaving. At Terrigal, we have members who have taken on Branch and State leadership roles e.g., SLSCC Surf Sports Director, Coaching, Team Managing, Education Tools/Systems, Selection Panel, officials. We now have a strong investment portfolio and have formal contracts with regular sponsors. We now have new Child Safe Coordinator and Complaints Manager roles filled to ensure safety/satisfaction.

Moving into 2024/2025, we are pleased to sign our new Lifesaving Agreement and we are excited to have our access to our upgraded clubhouse and continue to strengthen our leadership and youth development. I am proud of our success this season and look forward to continuing to keep our beach safe and be the leading community organisation in Terrigal. Thank you to SLSCC for your ongoing support of our club.

EDUCATION REPORT

This season has been a successful, if not demanding season for the education team, with over 80 new awards being granted and more than 450 re-qualifications completed by club members, both new and existing. All course fees, with the exception of Provide First Aid, were waived this year by SLNSW in an attempt to encourage volunteer members back after successive falls in volunteer numbers.

A significant challenge this year has been the lack of qualified trainers and assessors to assist in running courses. Previous years have seen over ten members within the education team, but this season volunteering has fallen to 7 trainers, three of which also undertake the roles of either Facilitator or Assessor. Allison Sharkey assisted with assessment of BM and SRC courses late last year also due to a lack of available assessors. Despite the challenges, the education team has worked successfully in delivering a range of courses.

Given the lack of trainers, the team had to be smart with the way courses were delivered this year. As such the SRC, Bronze Medallion, and SRC-to-Bronze transition courses were all delivered simultaneously over 6-8 weeks with SRC participants completing the first half of the course and SRC-to-Bronze participants dropping into the second half of the course. Course content was tailored to ensure all necessary material was provided to all.

This method presented many efficiencies for the team and avoided the need to deliver three separate courses during the year. It is suggested this method be used again next season, provided the numbers of participants versus the number of educators are sustainable. It also helped encourage some new members who started seeking only SRC, to progress for the extra few weeks and complete their full Bronze Medallion.

In addition, the education team have been using SLNSW's new online Assessment App for recording Bronze and SRC courses. Terrigal were one of the clubs on the coast that volunteered to trial the new app. The app is generally of benefit and helps educators to plan, track and submit course awards, but did not in the end cut down on manual paperwork. Feedback has been provided to SLNSW by our education team with regards to usage of the app.

A First Aid course was also organised for club members and paid for by the club for those undertaking their Bronze Medallion. The intent was to get all new BM participants to undertake the First Aid course, thus cutting down overall course time, but this proved unsuccessful as a) not all participants could make the course and b) not all members that undertook the First Aid Day completed the online components, despite correspondence from the education team to do so.

Moving Forward:

- Terrigal SLC is critically short of qualified trainers and assessors. Advertising for more volunteers will be essential, noting that the pathway to becoming a qualified trainer also takes time and effort. Suggest that at least two new trainers will be required for the coming and future seasons.
- Courses should be planned and advertised on the surf club website earlier, to provide new and existing members with dates and information in a timely manner. This has been done historically but was missed this season due to a change-over with DoE.

- Suggest that SRC, BM and BM-to-Bronze be delivered simultaneously depending on number of participants and dates, noting that some competition members require SRC-to-Bronze qualifications completed prior to the start of October for competition purposes.
- If First Aid courses are provided, the club should consider that individual members pay the course fee. TSLSC lost some revenue this season paying for qualifications that were not completed.

In summary, Surf Life Saving is built on education and training and without the dedication of trainers, assessors, and facilitators each year, the provision of a safe aquatic environment through Rescues, First Aids and Preventative Actions, would not exist. The debt of thanks cannot be overstated to every member of the education team who have given their time and energy to provide new courses and qualifications to over 80 club member this year and over 450 re-qualifications. An outstanding achievement.

ADMINISTRATION REPORT

Myself personally and the Board of Terrigal SLSC are absolutely thrilled for our club to WIN the Surf Life Saving Australia, Surf Life Saving NSW and Surf Life Saving Surf Life Saving Central Coast CLUB OF THE YEAR!! A schematic overview of our 2023/24 Strategic Initiatives can be found below. This was the culmination of extensive review and strategy regarding governance and club management, It has been a big year where the Board have been working on improved Governance and long-term strategy. Board meetings are now managed via BoardPro in line with SLSCC and this enables electronic uploading of reports and documents and more transparent and simplified sharing of documents and resources. Member documents are being shared via the SLSA member portal which means club documents are shared with members rather than the general public. This follows the advice of SLSCC.

A new Constitution was approved at the 2023 Annual General meeting with clearer alignment with SLSNSW policies and procedures. Previous By-Laws are no longer required and a set of Policies have now been developed and approved by the Board. These Policies are now available for all members via their SLSA Member Portal. The Director of Administration also digitised approximately 50 years of Terrigal SLSC Annual Reports. These are now electronically available and 'searchable' via the club website and SLSA member portal. This means Annual Reports are now readily available for all members and will be kept safely for years to come. This was been a huge job and I thank all who helped by providing old hard copies of reports. The digitisation has also helped with nominations for various awards and will continue to help in this area.



In recognition of members, we nominated people for OAMs with Cathy Cole's successful 98 SLSA awards (72 members): 59 Patrol Service Awards, 6 National Medals, 16 SLSA Long Service Awards (including 2x50-year long service awards). These nominations are not automatic and require tracking, review of criteria and nominations via an online portal but this is a real joy for me.

This past 12 months has also seen enormous work and effort as we move to deliver a complete renovation of our clubhouse. In late 2023, we delivered completely renovated First Floor bathrooms and in August 2024 we are ready to commence construction work on new ground-floor bathrooms, a renovated gym, a new entrance foyer and a renovation first floor training and function room. The new foyer will mean the café staff no longer have to enter our surf life saving club. New ground floor bathrooms will double the number of toilets available for members. At the end of 2022, it became clear that due to rising costs and changing member needs, a new training room and expensive rebuild of the surf club

was not financially viable and high risk for the club. It has been a complex and time-consuming process juggling Council, member requirements, architects, construction consultants, grant requirements etc. We have tried to manage all this while also balancing impact with finances.

Myself and others have attended workshops run by SLSNSW which have been great and 3 members will attend the Upcoming NSW SLS State Conference to ensure we are aligned with their Strategic Plan. Having been in the role for only 12 months, I can see there is much administrative work to do. We hope to have a full set of Director Position Descriptions before the 2024 AGM. All ByLaws have been replaced by the new Constitution, where possible, and Policies where there was a gap. We understand this is a change for some but this is an important step forward and will help improve consistency and transparency of governance decisions. Polices and other documents are all now available on the SLSA Members Portal.

I am thankful to al the volunteers at Terrigal SLSC who give so much of their time in pursuit of having a contemporary and inclusive and effective surf lifesaving club. The club takes many people to run it and each and every person is important to our success. Thank you Richard Green who has been an outstanding President and this was recognised by his Award for SLSCC President of the Year in 2023/24 season. Congratulations Richard! Thank you also to outgoing Directors Phil Clegg and Mandy Eyles who have made substantial contributions to the Board. Thank you to all members and Directors who have worked with myself and the Board in the 2023/24 season.

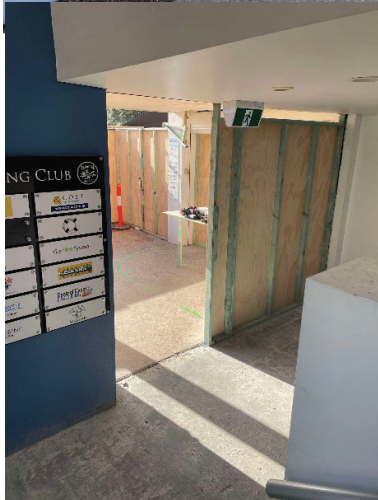
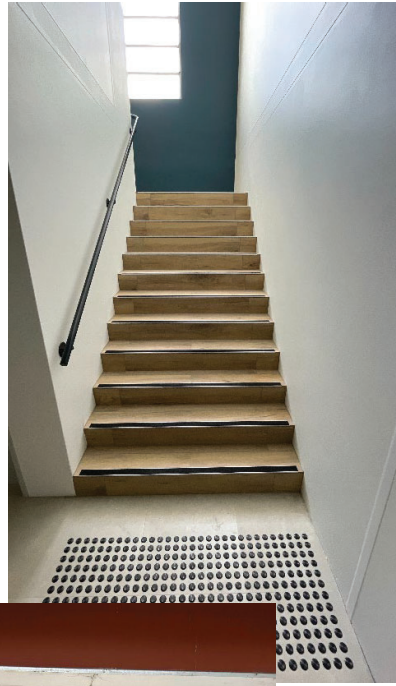
LIFE MEMBERS REPORT

Notes To The Financial Statements For The Financial Year Ended 30 April 2024

1. Summary of Significant Accounting Policies

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the *Associations Incorporation Act 2009*, the *Australian Charities and Not-for-profits Commission Act 2012*, the *Charitable Fundraising Act 1991* and associated regulations. The committee has determined that the association is not a reporting entity.

Terrigal Surf Life Saving Club Incorporated is an association registered under the *Associations Incorporations Act 2009* and domiciled in New South Wales.

The financial report is prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

These are special purpose financial statements that have been prepared for the purpose of complying with the *Australian Charities and Not-for-profits Commissions Act 2012* and associated regulations. The Executive Committee have determined that the accounting policies adopted are appropriate to meet the needs of the members of the Terrigal Surf Life Saving Club Inc.

These financial statements have been prepared in accordance with the recognition and measurement requirements specified by the Australian Accounting Standards and Interpretations issued by the AASB and the disclosure requirements of AASB 101 'Presentation of Financial Statements'; AASB 107 'Statement of Cash Flows'; AASB 108 'Accounting Policies, Changes in Accounting Estimates and Errors'; AASB 1048 'Interpretations of Standards'; AASB 1054 'Australian Additional Disclosures' as appropriate for not-for-profit oriented entities.

Accounting Policies

Revenue

Revenue is recognised when it is probable that the economic benefit will flow to the company and the revenue can be reliably measured.

Sale of goods

Sale of goods revenue is recognised at the point of sale, which is when the customer takes receipt of the goods, the risks and rewards are transferred to the customer and there is a valid sales contract. Amounts disclosed as revenue are net of sales returns and discounts.

Functions and Events

Revenue from functions and events are recognised once the event is held in the Club facilities and has meet its obligations to provide a venue for the expressed purpose agreed with the parties.

Membership fees

Revenue from membership fees is recognised at time of receipt.

Grants and donations

Grant & donation income is recognised as revenue when received unless they are designated for a specific purpose, where they are carried forward as prepaid income on the balance sheet.

Interest

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument.

All revenue is stated net of the amount of goods and services tax (GST).

Inventories

Inventories are measured at the lower of cost and net realisable value

Buildings

Buildings are measured on the cost basis and are therefore carried at cost less accumulated depreciation and any accumulated impairment losses. In the event that the carrying amount of buildings is greater than its estimated recoverable amount the decrease in value is shown in the profit and loss statement as a revaluation decrease

Plant and Equipment / Surf Patrol Equipment

Plant and equipment are measured on the cost basis and are therefore carried at cost less accumulated depreciation and any accumulated impairment losses. In the event the carrying amount of plant and equipment is greater than its estimated recoverable amount and impairment losses are recognised in the profit or loss as revaluation decreases if the impairment losses relate to the revalued asset. A formal assessment of recoverable amount is made when impairment indicators are present.

Depreciation

The depreciable amount of all fixed assets, including buildings and capitalised lease assets is depreciated on a straight line or diminishing-value basis over the asset's useful life to the entity commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

The depreciation rates used for each class of depreciable asset are:

Surf Patrol & Sports Equipment	20%

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at end of each reporting period.

Gains and losses on disposals are determined by comparing proceeds with carrying amount. These gains or losses are recognised in profit or loss in the period which they arise. When revalued assets are sold, amounts included in the revaluation reserve relating to that asset are transferred to retained earnings.

Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within short-term borrowings in current liabilities on the statement of financial position.

Goods and Services Tax

Revenues, expenses and assets recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office (ATO).

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included in other receivables or payables in the statement of financial position.

Income Tax

As the company is a charitable institution in the terms of subsection 50-5 of the Income Tax Assessment Act 1997, as amended, it is exempt from paying income tax.

Trade and Other Payables

Trade and other payables represent the liabilities for goods and services received by the company during the reporting period that remain unpaid at the end of the reporting period. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

Comparative Figures

Where required by Accounting Standards, comparative figures have been adjusted to conform with changes in presentation for the current financial year.

We note the previous auditor did not provide a reconciliation of the 2023 trial balance to the financial statements or access to their workpapers and files. Hence the comparative 2023 period is presented on a basis arrived at from other sources such as the business information systems and records of the Club.

Critical Accounting Estimates and Judgements

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that may have a financial impact on the entity and that are believed to be reasonable under the circumstances.

Qualified Opinion

We have audited the accompanying financial report of Terrigal Surf Life Saving Club Incorporated (the Club), which comprises the statement of financial position as at 30 April 2024, statement of profit or loss & other comprehensive income, statement of changes in members' funds and statement of cash flows for the year then ended, notes comprising a summary of material accounting policies and other explanatory information, and the committee members' declaration.

In our opinion, except for the effects of the matter described in the Basis for Qualified Opinion section of our report, the financial report of Terrigal Surf Life Saving Club Incorporated is in accordance with the *Australian Charities and Not-for-profits Commission Act 2012*, including:

In accordance with ASA510 Initial Audit Engagements, we have conducted audit procedures over the opening balances, however we were unable to obtain sufficient and appropriate audit evidence over some opening balances and subsequently adjusted some of these opening balances. Consequently, we were unable to determine whether all appropriate adjustments to these amounts were completed as necessary.

We conducted our audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Report section of our report. We are independent of the Club in accordance with the auditor independence requirements and ethical requirements of the Accounting Professional and Ethical Standards Board's APES 110 Code of Ethics for Professional accountants (the Code) that are relevant to our audit of the financial report in Australia. We have also fulfilled our other ethical responsibilities in accordance with the Code.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.
